The Bowls Club was originally formed in 1945 as part of the Lodge Plugs Sports facilities. Which later became Smiths Industries. Who in 1997 sold all the land for housing, which would have included the bowls club and green. But a group of bowlers brokered a deal and got ownership of the club.

Smiths Industries would not allow the club to use their name as part of the club`s so as the housing estate was going to called "The Grange Estate" it was decided to name the Club "The Grange Bowls Club" and also to use a spark plug as our badge emblem because of the original owners "Lodge Plugs".

The Club is owned by its members, so all day to day running costs, the major ones being electricity, water rates, gas, bar licence, maintenance, green and courts upkeep, must be met by the income generated from, Annual subscriptions, fund raising social events, bar takings and a small amount of sponsorship.

We have an active committee who are responsible for the day-to-day smooth running of the club.

All our committee, officers, bar staff and work party helpers are unpaid volunteers.
